

Invalda INVL is a leading Baltic investment management and life insurance group with an open approach, growing and developing, and creating well-being for people through its activities.



KEY CHANGES IN 2022

Invalda INVL had significant transactions in the asset management area in 2022:

- at the start of July, the acquisition of Mandatum Life's life insurance business in the Baltics was completed,
- late in the year, we signed an agreement on merging part of the retail businesses of Invalda INVL and Šiaulių Bankas.

These are fundamental steps in the development of a retail business geared towards a more mature society that seeks stable financial grounding and investment income.
